## Standard Open Account Agreement

As a Mats Inc. customer, and with your authorized signature on the Mats Inc. credit application, you are agreeing to pay Mats Inc. in full based on the terms and conditions of our credit agreement with you, which is, net thirty (30) days, unless otherwise specified in writing. In the event you fail to pay invoices within the terms of the credit agreement, and if the same is placed in the hand of a collection agency, you agree to pay all cost of collection up to and including reasonable attorney fees.

Your signature authorizes any person or credit-reporting agency to furnish Mats Inc. with credit information pertaining to your business or organization.

#### Sales Tax:

All resellers must attach a valid reseller certificate. Without a valid tax exempt certificate on file, Sales Tax will be charged and not refunded.

#### **Returned goods Policy:**

Requests for all returns of merchandise must be made to our Credit & Return Department. All returned goods will be assessed a 30% restocking charge and freight must be pre-paid. Returns can be made up to 30 days after the original ship date. Please contact our Credit & Return Department at 800-628-7462 for a Return Materials Authorization (RMA). Items returned without authorization or by collect freight will be refused. Items produced to customer specification, custom cuts, specialty items, logos, discontinued items, seconds, obsolete and used products cannot be returned.

#### Cancellations:

Orders may be cancelled within 24 hours of order placement. Custom orders cannot be cancelled once the manufacturing process has commenced. Stock items cancelled after shipping will be subject to a 30% restocking fee and any applicable freight charges.

### **Damaged Goods and Shortages:**

All orders should be counted and inspected prior to acceptance. Any damages or shortages must be documented on the POD (Proof of Delivery). In accordance with ICC regulations, the consignee is responsible for filing claims with the freight carrier. Contact the carrier immediately to file a claim and schedule an inspection. Keep your original packaging and photograph the damaged goods whenever possible.
